5.1 Extinguishing media

Suitable extinguishing media

: Highly flammable liquid and vapor. Fire will produce dense black smoke. Exposure to decomposition products may cause a health hazard. Runoff to sewer may create fire or explosion hazard.

7.1 Precautions for safe handling

: Vapors are heavier than air and may spread along floors. Vapors may form explosive mixtures with air. Prevent the creation of flammable or explosive concentrations of vapors in air and avoid vapor concentrations higher than the occupational exposure limits.
