APPLICATION INSTRUCTIONS

Application conditions

The surface to be painted must be dry, the temperature of the air at least +5 °C, and the relative humidity of the air below 80%. Note! Under the conditions mentioned above, drying is notably slower than under standard conditions (+23°C, relative humidity 50%). Drying of dark shades tinted with Symphony colorants is slowed down the most.

Surface preparation

Unpainted surfaces:

Remove all dirt, dust and grease.

Prime wood surfaces with Jehu primer and metal surfaces with Otex adhesion primer.

Previously painted surfaces:

Wash previously painted surfaces with Maalipesu cleaning agent, rinse carefully with water and let dry. Remove loose paint with a scraper and sand the whole surface. Remove the sanding dust. Fill holes and cracks with Presto Kalustekitti furniture filler or Lakkakitti lacquer putty. Sand the filled spots and remove sanding dust. If needed, prime with Jehu primer. Metal surfaces and surfaces industrially finished with acid-curing paint or lacquer should be primed with Otex primer.

Painting

Stir Maalarin Valkolakka when necessary. The product does not need to be diluted. Apply two coats by brush or roller. One coat is enough on surfaces that have been primed or previously painted with same color.

Maintenance painting:

Surfaces painted with Maalarin Valkolakka white lacquer can be maintenance painted with a similar paint or Helmi furniture paint. See pretreatment.

Cleaning of tools

Clean tools with White Spirit 1050 or Tikkurila Pensselipesu (Tool Cleaner). Clean tools with White Spirit 1050 or with Tikkurila Pensselipesu (Tool Cleaner).

Maintenance instructions

If needed, approx. 1 month after painting at the earliest.

Clean surface with a neutral (pH 6-8) dish-washing agent and a soft brush, sponge or a cleaning cloth. Clean very dirty surfaces with a mild alkaline (pH 8–10) washing solution and a cleaning cloth or sponge. Rinse the surface carefully.

The product achieves its final hardness and durability after one month under normal conditions, therefore the surfaces must be handled with care during a couple of weeks. If the surfaces need cleaning soon after surface treatment, clean them lightly using a soft brush or a damp cloth.

Maintenance treatment

Surfaces painted with Maalarin Valkolakka can be maintenance painted with same type of paint or with Helmi Furniture paint. See directions from section "Pretreatment".
