APPLICATION INSTRUCTIONS

Surface preparation

Clean the roof by removing leaves, debris and loose vegetation e.g. by brushing. Protect plants from possible splashes.

Application

Apply Kilpi Katonpuhdistaja to a dry, cleaned surface from bottom to top by using a brush or low pressure spray. Do not rinse the product off; instead, leave it to work on the roof.

Note

Do not use product if weather forecasts show rain and wind during day of application or at least for the next 6 hours of application. Cover unpaved soil, sensitive plants and surfaces not to be washed with an impermeable cover f.e. painters fleece. Cover glass and materials which can suffer from etching effect during prolonged contact. Rinse immediately with water when splashed on uncovered surfaces.
IF ON SKIN (or hair): Remove/Take off immediately all contaminated clothing. Rinse skin with water. Immediately call a doctor.

Recycle empty, dry cans or dispose them of in accordance with local regulations. Do not empty undiluted solution into drains, water systems and soil. Destroy the undiluted liquid waste according to the local regulations for hazardous waste.
