Drying time Touch-dry after approx. 4 hours. The porosity of the substrate and the amount of oil

used affect the drying time. The next treatment can be carried out after the surface

has dried.

#### APPLICATION INSTRUCTIONS

### **Application conditions**

The surface to be treated must be dry, the temperature of the air at least +5 °C and the relative humidity of the air below 80 % during treatment and drying.

#### Surface preparation

New impregnated surfaces must be allowed to dry for six months before treatment. Remove dirt, dust and loose material from the wood surface. Wash old and darkened wood surfaces with Homeenpoisto mold removal or Terassi- ja Kalustepesu power clean according to instructions.

Stir Ventti Puuöljy Ruskea well before use and occasionally during use. Spread the wood oil with a brush or a sponge, pressing the tool down tightly so that all the oil is absorbed into the wood. Wipe off any excess oil. Apply evenly and continuously along the length of a board.

#### Cleaning of tools

Clean tools with White Spirit 1050 or Tikkurila Pensselipesu (Tool Cleaner).

#### **Maintenance instructions**

Handle the painted surface with care, as the product achieves its final hardness and durability in about 1 week under normal conditions. The surface can be cleaned lightly after about 2 days after treatment using a soft brush, a damp cleaning cloth or a mop. A dirty surface can be cleaned with Pihan Huoltopesu (mix 1 part of Pihan Huoltopesu with 10 parts of water).

Clean stains and very dirty surfaces with a stronger solution of Huoltopesu and water (1:1). After washing, rinse the surfaces and allow to dry.

### Environmental protection and waste disposal

Avoid spillage into drains, water systems and soil. Destroy liquid waste according to the local regulations for hazardous waste. Recycle empty, dry cans or dispose them of in accordance with local regulations. Note! Risk of self-ignition of used cleaning rags, paper wipes etc. Contaminated materials can create fire some hours later and should be soked in water and placed in a closed metal container before disposal.
