Storage Protect from frost. Store in dry and cool place, protected from sunlight. A tinted

product or a product kept in a half-empty can will not withstand long-term storage.

APPLICATION INSTRUCTIONS

Application conditions

The surface to be painted must be dry, the temperature at least +5°C and the relative humidity of the air below 80%.

Surface preparation

Unpainted surfaces:

Clean the new surfaces by removing any dirt and dust. Fill the surfaces with a suitable Tikkurila Presto or Prestonit filler, if needed, and sand the dried surface. Remove the sanding dust.

Previously painted surfaces:

Wash previously painted surfaces with Maalipesu detergent. Fill the cracks and holes with a suitable Tikkurila Presto or Prestonit filler and sand the dried surface. Remove the sanding dust.

Water sensitive E.g. chalk painted or "structured" spray filler ceilings. Remove all loose or poorly adhering material, if needed, and prime with solvent borne Tixomatt primer.

Painting

Stir Ykköskatto well before use. Apply 1-2 times with a roller or spray.

Cleaning of tools

Clean tools with water. Tikkurila Pensselipesu Tool Cleaner is recommended to remove slightly hardened paint.

Maintenance instructions

If needed, after approx. 1 month from treating the surface, at the earliest.

Clean the surfaces with a well-squeezed, damp soft sponge or cleaning cloth and a neutral (pH 6–8) washing solution. Follow the dilution instructions given by the detergent manufacturer when mixing the washing solution. The surface may not remain wet after cleaning.

After surface treatment, surfaces must be handled with care for a few weeks, as the product will reach its final hardness and durability after about a month under normal conditions. If the surfaces need to be cleaned soon after finishing, clean them lightly with a damp cleaning cloth.

Maintenance treatment

Ceilings painted with Ykköskatto can be maintenance painted with the same or similar water-borne paint. See Pretreatment.

Environmental protection and waste disposal

Destroy liquid waste according to the local regulations for hazardous waste. Recycle empty, dry cans or dispose them of in accordance with local regulations.

Health and Safety

The product is not classified as hazardous according to Regulation (EC) 1272/2008 as amended. Wear protective gloves. Safety data sheet available on request. Contains 1,2-benzisothiazol-3(2H)-one (BIT) and reaction mass of 5-chloro-2-methyl-2H-isothiazol-3-one and 2-methyl-2H-isothiazol-3-one (3:1) (C(M)IT/MIT (3:1)). May produce an allergic reaction. This product contains a biocidal product for the preservation of the product during storage. Contains: C(M)IT/MIT (3:1) and BIT.
