DESCRIPTION

A one-component water-borne polyacrylate paint with good adhesion properties.

- · Very thixotropic and makes it possible to achieve a thick wet film without sagging
- A fast-drying paint for interior wooden parts of aluminium covered windows and interior doors. The paint protects wood against moisture and dirt
- · Good adhesion to bare wood
- Suitable for interior wooden parts of aluminium covered window frames and interior doors

Practical coverage depends on the application method, painting conditions and the shape and roughness of the surface to be coated.

Drying times

100–120 g/m²	+20°C	+40°C
Dust dry, after	30min	15min
Touch dry, after	40min	30min
Dry to sand, after	1h	30min
Dry to handle, after	2h	30min

Stacking temperature below +30°C.

Drying and recoating times are related to the colour shade, film thickness, temperature, the relative humidity of the air and ventilation.

APPLICATION INSTRUCTIONS

Surface preparation Clean surfaces from dirt, dust and loose material. Assure that surface is free from mold

> and blue stain. Wood surfaces must be sanded with sandpaper P150-320. Sanding prior to the next application with sandpaper P240–400. All sanding dust must be removed.

Recommended primers Pinja Combi AW 20.

Application conditions The surface to be treated has to be clean and dry. The moisture content of wood has to

> be below 20%. During application and drying temperature of the air, substrate and the product must be over +18°C and relative humidity of the air below 70%. Good ventilation

is required to ensure optimal result. Product can be dried with or without oven.

Application For airless spraying recommended nozzle tip is 0.011"-0.015" and pressure 80-160 bar.

Spray angle shall be chosen according to the shape of the object.

For air-assisted airless spraying recommended nozzle tip is 0.011"-0.015" and pressure

40–120 bar. Spray angle shall be chosen according to the shape of the object.

Wood contains resin and other colouring extractives especially in knots. Temperature

and humidity fluctuations may cause paint coat discolouration in these areas.
