11.1 Information on toxicological effects

There is no testdata available on the product itself.

Exposure to component solvent vapor concentrations in excess of the stated occupational exposure limit may result in adverse health effects such as mucous membrane and respiratory system irritation and adverse effects on the kidneys, liver and central nervous system. Repeated or prolonged contact with the mixture may cause removal of natural fat from the skin, resulting in non-allergic contact dermatitis and absorption through the skin. Based on the properties of the epoxy constituents and considering toxicological data on similar mixtures, this mixture may be a skin sensitizer and an irritant. Repeated skin contact may lead to irritation and to sensitization, possibly with cross-sensitisation to other epoxies. If splashed in the eyes, the liquid may cause irritation and reversible damage. Ingestion may cause nausea, diarrhea and vomiting.
